

# Lincoln's Inn Dampier MSS Index

Reference Keys are as in the original paper slip index:

- LPB = Lawrence paper book.
- BPB = Buller paper book
- APB = Ashhurst paper book
- PBD = Paper book, Dampier

Notes: In the original index, consisting of slips of paper, cases using the "fictional lessee", John Doe, in the form "Doe d. Taylor [Doe on the demise of Taylor] v. Abingdon" are sorted first by "Doe d." then by the defendant's name, "Abingdon". Names of churches are sorted usually by the name of the town or city, e.g. "R. v. St. James, Bury St. Edmunds" is sorted as "R. v. .... Bury St. Edmunds".

Where an MS is marked with an additional "a" "b" "c" "d" etc., the "a" etc. is marked with full stops on either side so that it can be accurately searched, as ".a." ".b.", e.g.

"Barton v. Webb 1800 LPB 309.a. unreported" and also to be distinct from "d." standing for "on the demise of".

Not all cases have been checked to see if they are reported or not. The original index has been found to be inaccurate in a number of instances and has been corrected where found. The subject indexes show report citations.
