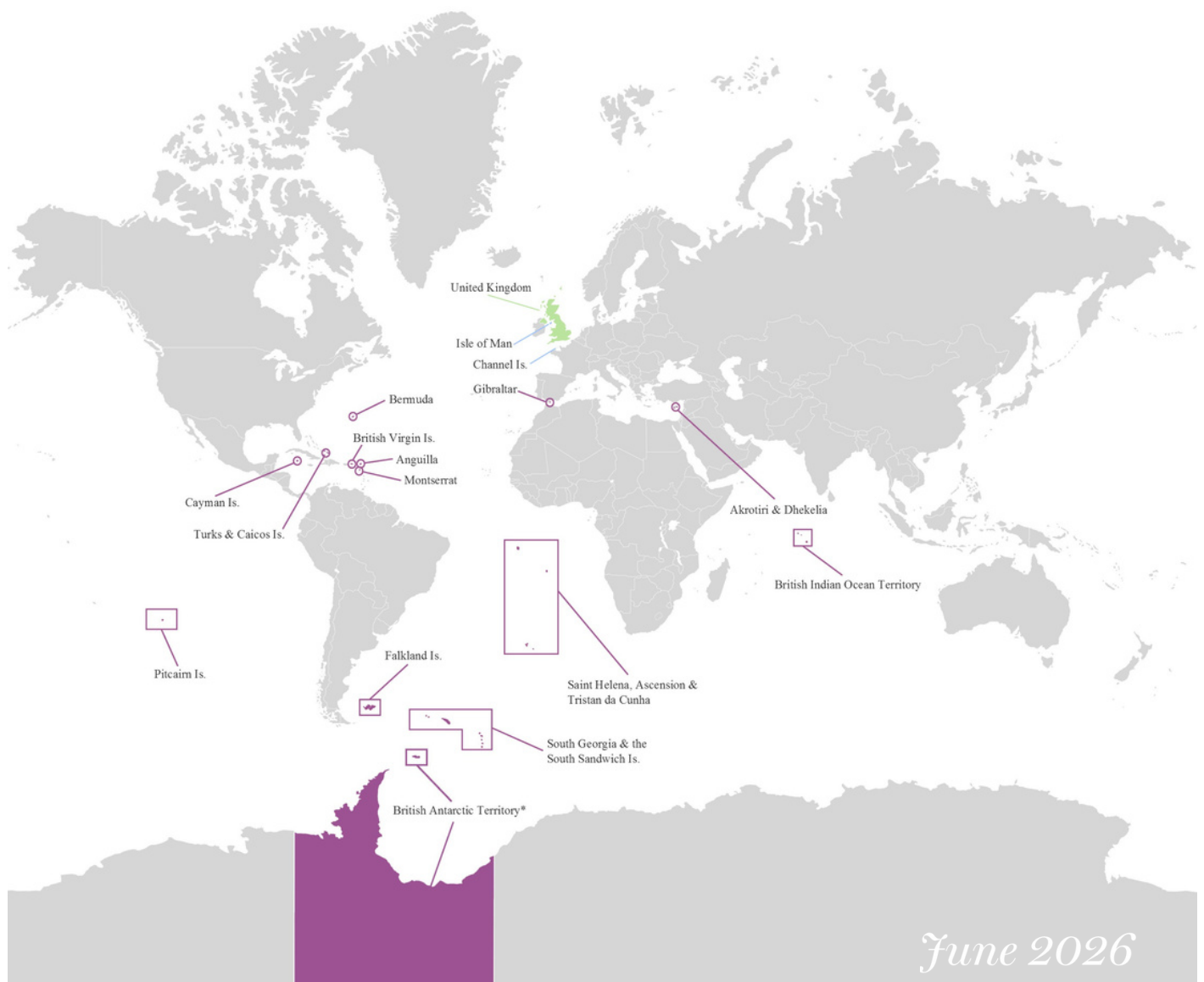

Introduction

Tips for using these fields to find British Overseas Territories material follow.

Catalogue Guide

Textbooks

The catalogue record for textbooks primarily about British Overseas Territories jurisdictions should include that jurisdiction name as a subject, so include this term in the *subject* field.

The catalogue record for textbooks with only a chapter or section on the law of a jurisdiction may only include the reference in a note, so include the jurisdiction name in the *words or phrases* field.

To search for the latest editions of textbooks, change the *type* field to *Latest edition held*. To search for old editions of textbooks, change the *type* field to *Old edition*.

Legislation

The author of legislation will be the relevant jurisdiction name in the author search field.

Change the type field to Legislation.

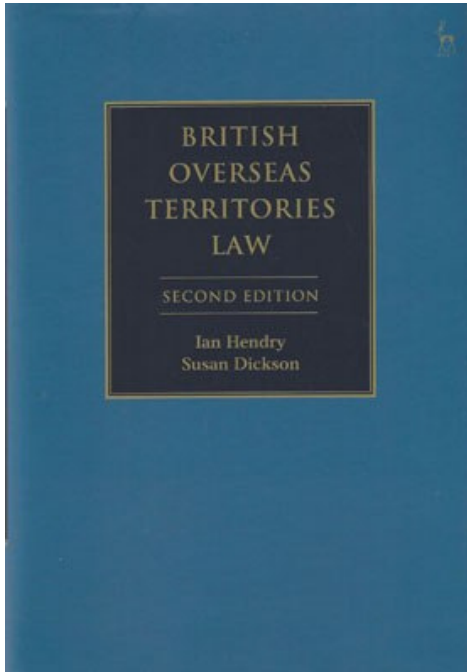
Law Reports & Journals

The catalogue record for British Overseas Territories serials (Law Reports & Journals) should include the jurisdiction name as a subject, so include this term in the subject field.

Change the type field to Journals or Law reports as required.
