

Bar Student Welcome Handbook

2021/22

I am delighted to welcome you as a student member of Lincoln's Inn. The Inn plays an important role during your Bar Course year and in this booklet you will find more information on the events and activities on offer at the Inn.

Firstly, can I ask that if you no longer intend to undertake the Bar Course this year that you please email <u>education@lincolnsinn.org.uk</u> to let us know as soon as possible.

Despite the easing of the pandemic restrictions, this year is likely to not be a completely normal one. We are aiming to provide as many of our usual services for students as possible, although some may be online and others may not be able to take place, depending on restrictions at the time. At a minimum we will ensure that you have plenty of opportunities to undertake your qualifying sessions and that we keep you updated on things as they change throughout the year. Our plan for our non-interactive qualifying sessions is to hold them as hybrid events so that you can join either in-person or remotely. For our interactive qualifying sessions, our plan is to hold them in-person; at the Inn, near the Bar Course Providers around the country, and at the residential student weekends. This is because these sessions are delivered more effectively in-person and you will get more out of these sessions by attending in this way. However, we will keep this approach under review.

In order to give you further information about the Inn we will be holding an introductory event for new students in September. Normally this would be held inperson but given the current situation it will be held online. I strongly encourage you to attend if possible as it will provide you with important information for your Bar Course year and is an excellent opportunity to meet our team and ask any questions you may have about the Inn. In this booklet you'll find some brief information about qualifying sessions, events and schemes for student members, Call to the Bar, support, and more. Detailed information on our provision for student members and all the Inn's services, facilities, and events can be found on our website. Also enclosed is some information about becoming a Student Representative for your Bar Course Provider, a Committee member of our Students' Association or Secretary for the Debating and Mooting Clubs. I would particularly recommend that you consider applying for these roles. Further information on these roles and the application forms can be found within this welcome pack.

As well as the events and activities provided specifically for our student members, the Inn also organises a range of social, wellbeing, professional development and networking events which are open to all members. To find information on upcoming events for members, please see the What's On section of our website. I hope that you find the Inn's events and activities useful and enjoyable. Qualifying Sessions


Students are required to complete ten qualifying sessions, during a period of no more than five years, ending on the date on which they are called to the Bar. This is laid down in the <u>Bar Standards Board Regulations</u> and the <u>Joint Inns' Education and</u> <u>Qualification Rules</u>. If you commenced the course prior to July 2020, you are required to complete twelve qualifying sessions. Please visit our <u>transitional arrangements page</u> to find out further information on how these changes affect you.

Qualifying sessions form a vital part of a student's journey in training to become a barrister. They provide opportunities for professional and ethical development which complements and builds on a student's academic and vocational education and forms a bridge to the final component of Bar training, pupillage. Qualifying Sessions also offer opportunities for students to enhance their understanding of the role of barristers in the wider justice system and the rule of law.

Qualifying Session Themes

It is now a requirement that all students complete at least one session from each of these themes and within these two interactive qualifying sessions must be completed. For students who attended qualifying sessions prior to June 2020, there is no obligation to do so but we would strongly encourage you to attend as many types of sessions as possible, in particular the interactive sessions. Students must take part in all elements to be credited.

- Ethics, Standards and Values
- Advocacy Skills
- Legal Knowledge, Justice and the Rule of Law
- Equality, Diversity and Inclusion
- Preparation for Pupillage, Career Development and Wellbeing

Qualifying Sessions

When to attend your qualifying sessions

Please do not leave it too late to complete your qualifying sessions as this may affect the date on which you can be called to the Bar. There are four Legal Terms: Michaelmas, Hilary, Easter and Trinity. The Inn holds qualifying sessions during each Legal Term. The number of qualifying sessions in each term varies, with the Easter and Trinity terms having the fewest events. Do plan ahead and think carefully about which qualifying sessions you wish to attend so that you do not need to fit a large number in at the end of the academic year. We strongly encourage students to complete their Qualifying Session requirements whilst studying the Bar Course as fewer opportunities will be available once you have finished your studies. The Inn will be providing a mixture of hybrid and in-person qualifying sessions this year.


Furthermore, students studying at outside of London will be able to complete some of their qualfying sessions locally. These events are organised by the Inn.

Student Activities

Marshalling Scheme

Marshalling involves a student accompanying a judge at a particular court over a one to three day period. Our judicial members participating in the scheme do so voluntarily and warmly receive marshals. To apply please complete and submit the application form <u>on our website</u>.

Bar Course Student Representatives

- Reporting matters of concern affecting the students at their Bar Course Provider.
- Sitting on the Lincoln's Inn Students' Association (LISA) Committee and contributing to the meetings.

Debating And Mooting Secretaries

The Debating and Mooting Secretaries assist the Education Department with arrangements for the Club Workshops. The Secretaries must be students at London Bar Course Providers. Debating and Mooting activities at Providers outside London can be organised by the Student Representatives at their Bar Course Provider if there is demand for this and the Secretaries may be required to assist with this.

Two Secretaries will be appointed for each Club. The Secretaries are also expected to attend meetings of the Students' Association Committee (LISA). Further information on these roles and the application forms <u>can be found here</u>.

Call

Call to the Bar will be available to those who have passed their Bar Course, completed their criminal records checks, and who have completed the required number of Qualifying Sessions Including themes and interactive sessions. Call Days take place once per term and slots are offered on a first come, first served basis. Details on when the Call Days are held are on our website, and the opening of Registration of Interest for Call will be communicated in the Students' Newsletter. A Call Declaration must be completed prior to Call and posted to the Inn.

Due to the requirement to undergo criminal records checks ahead of Call, registration of interest may be required to be submitted up to nine months ahead of each Call Date. You are able to register interest in advance of receiving your Bar Course result, and also prior to completing your Qualifying Sessions. It is a students' responsibility to keep up to date with current Call deadlines, which are regularly updated on the Inn's <u>Call webpage</u>. The Inn may not be able to accept requests for Call after certain deadlines have passed.

Applying for Pupillage

Wellbeing Assistance Programme

The Wellbeing Assistance Programme is a joint initiative between the Inns, targeted at providing professional mental health and wellbeing support services to junior members of the Inns delivered by independent health and wellbeing provider <u>Health Assured</u>.

In summary, the Programme provides:

- Telephone helplines offering practical information and emotional support.
- Medical information.
- Online health and wellbeing portal including wellbeing resources and a mobile app.
- Face to face counselling sessions.

Eligibility Criteria:

- Have completed the Bar Course within the last five years.
- Have not commenced pupillage.
- Reside permanently within England and Wales.
- Intend to apply for pupillage in England and Wales.

Students should seek the counselling and wellbeing services provided by their Bar Course Provider in the first instance but are able to contact the Education Department (education@lincolnsinn.org.uk) about this programme if they feel that they are unable to access these services.
