“There are three island territories within the British Isles that are known as Crown Dependencies; these are the Bailiwicks of Jersey and Guernsey which make up Channel Islands, and the Isle of Man. The Crown Dependencies are not part of the United Kingdom, but are self-governing possessions of the British Crown.”

The catalogue provides a selection of search fields that can be used in combination to identify and locate potentially relevant material.

Tips for using these fields to find Crown Dependencies material follow.

Catalogue Guide

Textbooks

The catalogue record for textbooks primarily about Crown Dependencies jurisdictions should include that jurisdiction name as a subject, so include this term in the *subject* field.

The catalogue record for textbooks with only a chapter or section on the law of a jurisdiction may only include the reference in a note, so include the jurisdiction name in the *words or phrases* field.

To search for the latest editions of textbooks, change the *type* field to *Latest edition held*. To search for old editions of textbooks, change the *type* field to *Old edition*.

Legislation

The author of legislation will be the relevant jurisdiction, so include the jurisdiction name in the *author* search field.

Change the *type* field to *Legislation*.

Law Reports & Journals

The catalogue record for Crown Dependencies serials (Law Reports & Journals) should include the jurisdiction name as a subject, so include this term in the *subject* field.

Change the *type* field to *Journals* or *Law reports* as required.

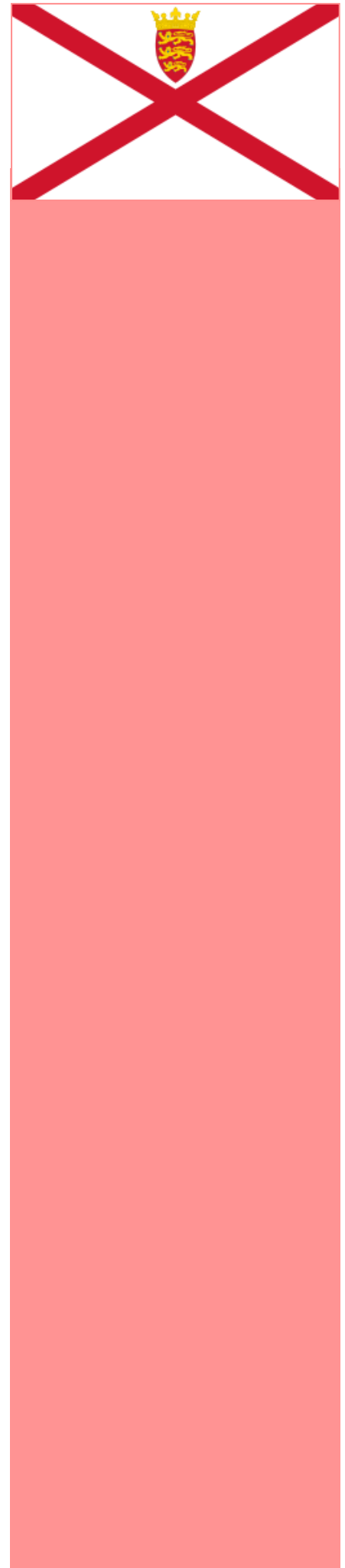

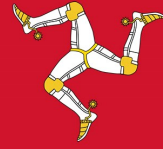

Judicial Committee of the Privy Council

The court of final appeal for the UK's overseas territories, crown dependencies (Jersey, Guernsey and the Isle of Man), and military sovereign base areas, and for several Commonwealth countries. Includes lists of relevant legislation; procedural information (forms, rules and practice directions); details of current cases and future sittings; live television coverage of hearings; and judgments ("Decided Cases") November 2009 onwards. (For judgments from 1999 to August 2009 and selected key judgments before 1999 see either the BAILII web site (to which a link is provided) or archived content on the Privy Council Office site.)
